Hauraki School **Policy Document Travelwise**

Rationale:

Hauraki is committed to being a Travelwise school that encourages a whole school culture of safety and sustainable travel.

Purposes:

- To ensure as a school and community we encourage the safe travel of all children attending
- Hauraki School recognises the responsibility it has to promote Travelwise options.
- To provide information and guidelines on Travelwise options for travel to and from school.

Guidelines:

- 1, Definition: Travelwise is an innovated programme facilitated by the Auckland Transport to make school travel safer, healthier and more fun. Aims include:
 - Encourage and increase use of active travel modes and public transport
 - Provide safer facilities for all road users
 - Reduce congestion around school
- 2. This policy should be read in conjunction with our Safe School Travel Plan that contains meaningful goals and practical actions to create a safer and less congested environment outside the school.
- 3. Hauraki encourages students to walk, cycle, or scooter to school, in the interests of improving the health and fitness of students, and in order to alleviate traffic issues at peak hours around the school.
- 4. If children are cyclists or scooter riders under the age of 9 years they need to be accompanied by an adult to and from school at all times. Children are expected to wear a helmet and high visibility vest. See appendix 1.
- 5. Cyclists and scooter riders who are 9 years and upwards may cycle/scooter independently subject to a satisfactory bike/scooter safety test and written parental permission. See appendices 2 and 3.
- 6. Students should be strongly encouraged by home and school to adhere to road and pedestrian rules when walking, cycling, or scootering.
- 7. The school will provide a designated area for bike and scooter storage but will not accept any responsibility for lost or damaged bicycles, scooters, helmets or vest.
- 8. Walking school bus routes that are dependent on parent availability are strongly encouraged and listed on the school website. For walking bus driver guidelines see appendix 4.

Appendix 1

- 1. To be able to cycle or scooter independently to school students should adhere to the following:
- Be a minimum of 9 years old
- Wear a safety-approved, correctly fitted helmet and high visibility vest
- Have participated in a cycle or scooter safety lesson conducted by the Police Education Officer or Deputy Principal
- · Have had their bicycle or scooter checked by a parent/guardian to ensure that it is safe
- Have had the form (appendix 2) signed by their parents/guardians stating they have responsibility for their child's safety when riding to and from school.
- 2. Bike safety lessons take place within the first two months of the school year and thereafter each term for the remainder of the year at a time suitable to the Police Education Officer and/or Deputy Principal.
- 3. When students arrive they are to dismount on the corner of Walter Street and wheel their bike or scooter down the footpath, cross at the school crossing, then wheel to the designated storage areas within the school grounds.
- 4. Bicycles and scooters should be taken home each day.
- 5. Students are to provide their own chains and combination locks if they wish.
- 6. No tricks or jumps are permitted on school grounds or surrounding footpaths.
- 7. Riding a bike or scooter in the school grounds is strictly forbidden when arriving or leaving school.
- 8. Permission to ride to and from school may be revoked at any time due to dangerous or unsafe cycle or scooter practices for a period determined by the Principal or Deputy Principal.

Appendix 4

Walking School Bus Driver Guidelines

Walking School bus drivers are responsible for children's safety to and from the designated 'bus stops' and for seeing 'their' children safety on and off the bus. The following guidelines should be adhered to at all times:

- 1. The bus driver should always walk at the front of the group.
- 2. A high visibility vest should be worn by the driver.
- 3. A ratio of eight children to one adult is recommended.
- 4. The driver should stick to the agreed route at all times.
- 5. Children should always walk and never run.
- 6. Encourage children to walk together and not get too far behind.
- 7. Be prepared to share the footpath with others.
- 8. Point out to children potential dangers, in particular, sneaky driveways.
- 9. Remind children to listen and obey instructions especially in regard to stopping crossing the road.
- 10. If there are crossings on your route you must use them.
